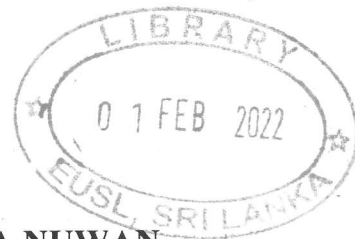

Thus, this study intends to investigate the Level of Organisational Factors and Green Banking Practices, the Relationship Between Green Banking Practices and Organisational Factors, and the Examine the Impact of Organisational Factors on the Green Banking Practices in the Banking Sector in Sri Lanka.

In this research study, primary data had been practiced by this study. A structured questionnaire was used as the method of data collection. The Stratified convenient sampling method used to make the sampling framework of the study. The quantitative research approach used for this study.
